**Parent & Educator Training on Multiple Topics**—*Special Education Rights, Transitions (Preschool, Kindergarten, Middle, Adult), 504, Evaluations and Assessments, Inclusion and Least Restrictive Environment, Conflict Resolution, IEP Development, Literacy, Diagnosis/Disability Specific Workshop, Response to Intervention, Guardianship, Independent Living, Financial & Estate Planning and more! Some trainings are free, and some include minimal charge to cover materials.*

**LifeLine IEP Consultants** serve families with children birth to age 22, regardless of diagnosis (or even if you are still trying to find a diagnosis). Most IEP Consultations take at least 2 hours. \$50 fee per consultation.
